

ORDINANCE NO. 176

AN ORDINANCE TO AMEND SECTIONS 7 AND 8 OF ORDINANCE NO. 67 AND REPEALING ORDINANCE NO. 74 IN ITS ENTIRETY AND BY ADOPTING A NEW SECTION 7 AND 8.

THE CITY OF LUNA PIER ORDAINS:

Section 7 and 8 of Luna Pier Ordinance No. 67 is hereby repealed and Ordinance No. 74 in its entirety.

SECTION 7: Sewer Permits

- A. Permits shall only be issued and work shall be performed only by a contractor that has been approved by the city.
- B. Any person requesting a new sewer tap where a riser is not presently installed shall first obtain a permit consisting of a tap fee and inspection fees.
 - 1. Tap fees shall be: \$1,500.00 for Residential, \$2,000.00 for Multi-Family and \$2,500.00 for Commercial.
 - 2. Inspection fees shall be: \$30.00 per required inspection.
 - 3. For approved additions to a riser on Multi-Family or commercial projects a permit fee of \$50.00 plus \$30.00 per inspection shall be required.
- C. Disconnection or discontinuation of sewerage service shall be permitted by an approved contractor provided:
 - 1. Sufficient cause for the disconnection is provided.
 - 2. A permit is first obtained from the city.
 - 3. A permit fee of \$40.00, which includes one inspection, plus \$30.00 per additional required inspection is paid.
 - 4. Thereafter the sewerage disposal service charge shall terminate upon the date the next charge shall be due.
 - 5. Work is inspected and approved by the designated city inspector.
- D. Re-connection of sewerage service to an existing and previously in service riser shall be permitted by an approved contractor provided:
 - 1. Sufficient cause for the re-connection is provided.
 - 2. A permit is first obtained from the city.
 - 3. A permit fee of \$40.00, which includes one inspection, plus \$30.00 per additional required inspection is paid.
 - 4. Upon connection the sewerage disposal service charge shall immediately be added to the tax roll and shall be paid when the next charge shall be due.
 - 5. Work is inspected and approved by the designated city inspector.
- E. Repair or service to an existing sewerage line shall be permitted by an approved contractor and/or person approved by the building department provided:
 - 1. A permit is first obtained from the city.
 - 2. A permit fee of \$40.00, which includes one inspection, plus \$30.00 per additional required inspection is paid.
 - 3. Work is inspected and approved by the designated city inspector.

SECTION 8: Bonding.

In addition to permit and inspection fees the city may require at its discretion a deposit of cash or other instrument suitable to the city, in the amount of the cost as estimated by the city to cover excavation, taps, running of the riser or sewerage line, road repair, and restoration of the effected area which sum shall be deposited with the City Clerk. Said bond shall be forfeitable to the city, automatically, 10 days after notice to the applicant that the project requirements have not been met. Thereafter, the city shall be authorized to go onto the property and utilize bond funds to complete the project in accordance with all requirements.

This Ordinance shall become effective ten (10) days after a summary has been published as provided by law.
